Earlier this week, as the one hour turned into... more, it was reaffirmed that while sailing can be alone on the water, pulling a boat is to be shared. Newer members, never be shy about reaching out for help or guidance; we've all been there at one point or another. When members connect with each other, we sustain each other in the use and enjoyment of Upper Klamath Lake.

With the change in seasons, it is a good time to reflect. Since June this year, Liz and I have seen the support and pulling together of members, moving forward to do good things.

<u>Accomplishments include:</u> *reformation of the New Membership Committee with information sent out quickly; *upon Board approval, new members AND their sponsors welcomed the next day by email; *detailed tentative agendas being posted prior to monthly Board meeting; *sharing Board meeting highlights the week following the meeting; *missing annual and board meeting minutes added to website; *club emails reduced to weekly unless urgent business; *weekly communication and information posted at club entryway board; and *the First Friday added-celebration of "Hail and Farewell".

On-going work includes: *Handbook Committee work to get a Club Handbook posted to the website; *Budget Committee preparation for club-wide presentation of an annual working budget; *new Club 'water-bottle-style' stickers to be made available to all members this fall; *membership cards written and issued by Secretary Valerie Gravelle in October; *map drawn-up of 2023 boat moorage and storage with identification of long-term unused boats and unknown(!) boats; *general club grounds work with ramp repair, workroom clean-up, sprinkler head repair, wheel replacements on hose cart and wheelbarrow; *updating club wall trophies 2020-21 with Sam Houston guidance; *updating annual racing trophies from 2014 on with Mike Bliss guidance; improving communication with club members via website use with Greg Collins' invaluable knowledge and legwork. *By now, multiple emails per membership should be receiving KYC weekly messages and if not, please contact Greg or Steve and Liz.*

Looking forward and what-is-to-come includes: *a printed club handbook for interested members; *committee work on director and officer duty lists; *Board-approved and published updated KYC Policies & Rules document; *meeting by the Project Planning Committee, and *regular service to the Club.

<u>The fall Special Annual Meeting</u> is for club members only (no guests) and will address member survey results and work being done to address such, review February 2023 Annual Meeting Minutes, hand out membership cards, and present other information as needed. Club Grounds Report

As we move into the autumn season, KYC club grounds present some new needs and upkeep to be addressed by our members. This is a good time to get in those outdoor work hours. As always, there are weeds, branches, fallen apples, miscellaneous garbage that has blown around, riffraff washed up onto the ramp, and left-behind items from people. (Speaking of, if you've misplaced a sticker-covered water bottle or a brand-new ARTIC lunchbox/cooler, they've been found. Let the Campbells know.)

The lake level has significantly dropped, presenting problems for trailer use at the ramp. If you are not trained in using the crane, please contact Stephen King, Mike Bliss, Jake Zaiger, Greg Collins, Tim Phillips, Mick Mulvey, Steve Campbell, or Vince Wachter. As per club policy, DO NOT USE THE CRANE without training.

Trailers should have inflated tires and be unlocked, as during this time of year especially, boats and trailered boats are being moved around to make room for boats coming off the water. Boats are being "stacked" into the northern parking lot for winter storage. If you have a special concern about where your trailered boat will be placed for the winter, please contact Steve and Greg. We want most everyone happy but need to do it in an orderly and safe way.

Please do not leave boats and/or trailers parked on the southern grass lot; it is temporary use at best. The club lawns are still being watered and mowed.

ALL BOATS MUST BE OUT OF THE WATER BY NOVEMBER 1st; don't push your luck waiting until then though. See Club Policies & Rules if you have a question about fees assessed after November 1st if your boat is not out of the water.

The end-of-August work party was successful. That being said, the outside-accessed workroom will only stay usable if members show responsibility and respect by cleaning up after themselves, knowing that the workroom is used by many throughout the year. Not every tool you need is there, but there are tools, chains, straps, hooks, bolts, fenders, and the like.
